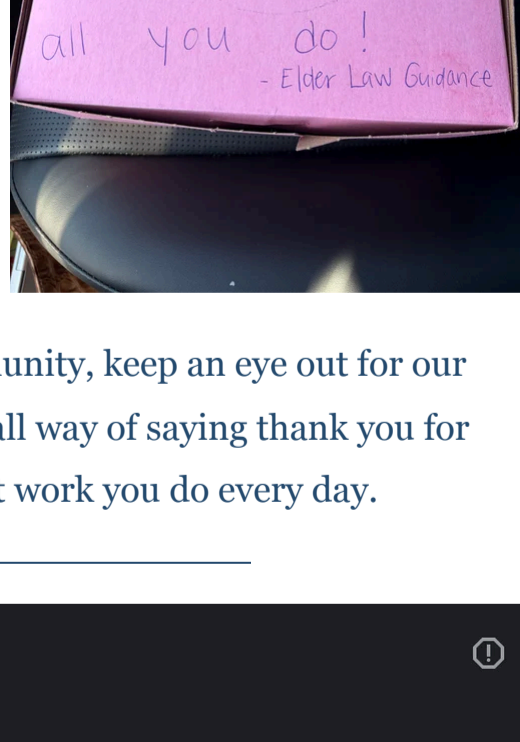
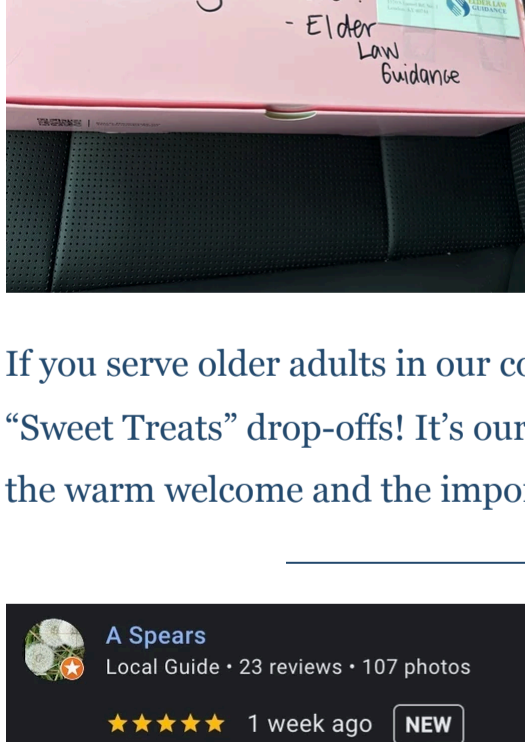


June 15th is World Elder Abuse Awareness Day!

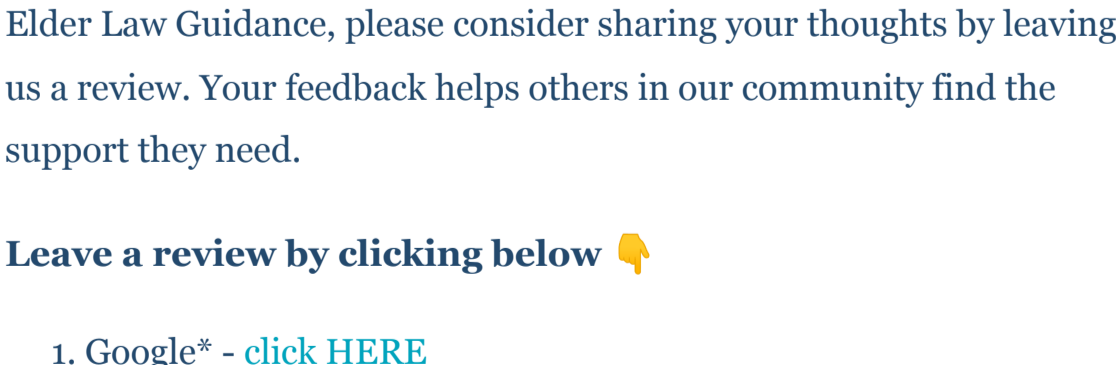
