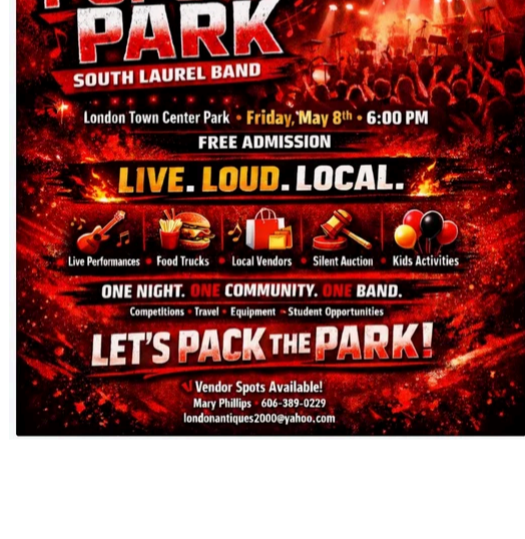
CEMP Spring Forum Fundraiser - FREE event, May 15th

Hosted on Zoom, our educational webinars cover elder law topics. The live webinars are hosted by Attorney's from ELG and include a Q & A session - bring your questions!

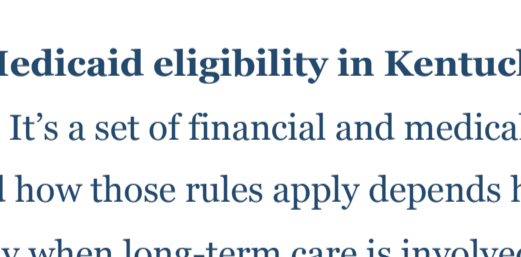

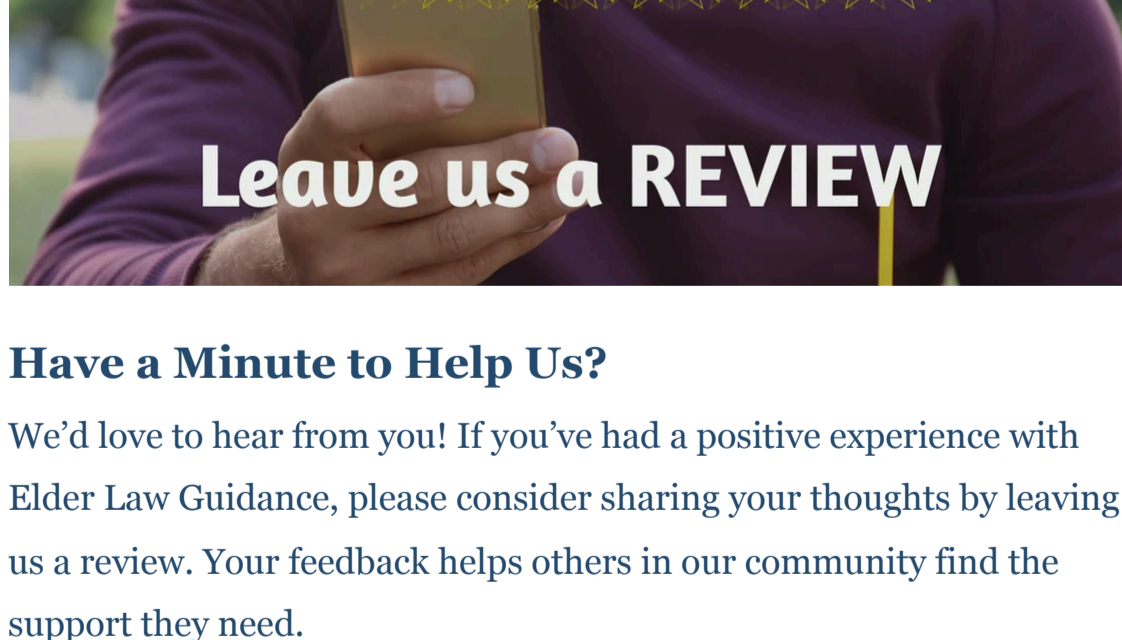

Kentucky Medicaid Requirements - What Families Need to Know Before Applying



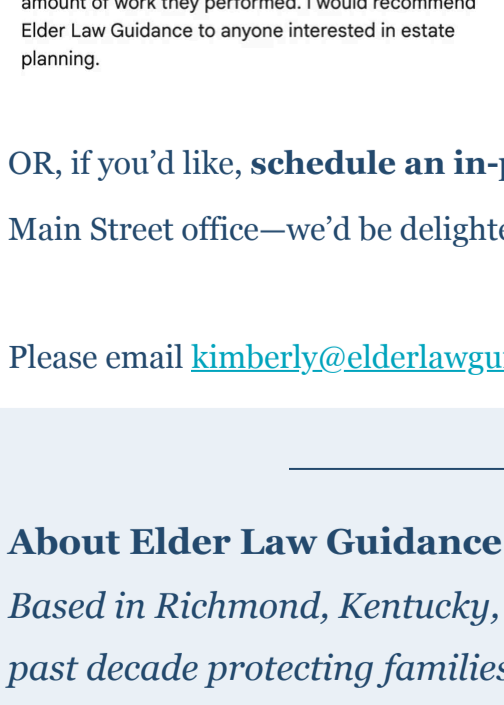
